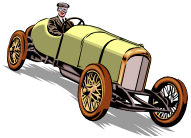

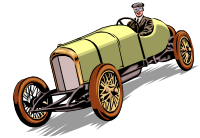

RELEASE OF LIABILITY & ASSUMPTION OF RISK AGREEMENT

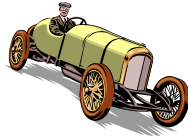

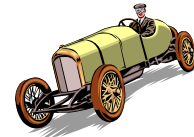
